NLC Releases Report on Successful Local and Regional Practices in Response to Foreclosures: This month the National League of Cities (NLC) released *Resilience in the Face of Foreclosures: Lessons from Local and Regional Practice*, a research report focused on addressing the foreclosure crises facing many regions today. The report highlights six metropolitan regions and their local and regional responses to the increasing rate of foreclosures and neighborhood decline, and offers practical strategies for implementation across the country.

USDA Updates Online Food Environment Atlas: The U.S. Department of Agriculture (USDA) recently updated their online mapping tool to feature 78 new indicators of the food environment at the county level. The Atlas includes indicators such as availability of food stores and restaurants, food prices, socioeconomic characteristics and health outcomes. The updated Atlas can be accessed **here**.

EDA and IEDC Launch RestoreYourEconomy.org: The International Economic Development Council (IEDC), with support from the U.S. Economic Development Administration (EDA), recently launched www.RestoreYourEconomy.org, a website to support regions recovering after a disaster. The website features resources and best practices for planners and the business community to prepare for and recover from major disasters that impact local and regional economies.

rules that govern federal programs. The Act was introduced by Congressman Geoff Davis (R-KY) and is co-sponsored by several Republicans. If enacted the REINS Act would require a vote from Congress before any regulation with an economic impact of more than \$100 million could go into effect (e.g. U.S. EPA's greenhouse gas regulations which have congressional scrutiny). Report Released on Tying Transportation to Economic Growth: The Bipartisan Policy Center's National Transportation Policy Project recently released the report, "Strengthening Connections Between Transportation Investments and Economic Growth." The report to Congress explains that transportation projects are more than just about job creation and urges Congress to consider diverting funds from existing programs that provide "guestionable job-creation, unclear long-term benefits or if the programs are solely an effort to increase short-term employment." The recommend that Congress prioritize projects by balancing job creation with long-term benefits. Click **HERE** to access the report.

DOT Secretary LaHood Shows Confidence in Moving Transportation Authorization Bill: U.S. Department of Transportation (DOT) Secretary Ray LaHood told an audience in Atlanta last week that he is confident a multiyear bill to reauthorize the nation's surface transportation programs can be passed by Congress and signed into law before the congressional summer recess begins in August. LaHood restated the Administration's opposition to increase federal gasoline and diesel taxes on gasoline and diesel to fund transportation. Click **HERE** for more on the speech.

House to Vote this Week on Reducing Federal Spending: The House Rules Committee approved a resolution (House Res. 38) last week that would authorize the chairman of the House Budget Committee to set reduced spending levels for the remainder of the federal fiscal year to FY08 levels or less. The full House is expected to consider the measure today. Under the House rules package adopted on January 5, House Budget Committee Chairman Paul Ryan (R-WI), was given the power to set a limit on FY11 appropriations in the House in lieu of a budget resolution - this is only for non-security discretionary spending. House appropriators are expected to cut \$55 to \$60 billion.

Senate to Host First Transportation Reauthorization Hearing: The Senate Environment and Public Works Committee will being its discussion of a surface transportation spending bill with a hearing this Wednesday, January 26 at 10:00am ET in 406 Dirksen. The hearing, which will focus on job

U.S. EPA Clean Diesel Emerging Technologies Funding

Assistance Program - Deadline: January 27, 2011

The U.S. Environmental Protection Agency requests proposals for the Clean Diesel Emerging Technologies Funding Assistance Program. This RFP will support projects that achieve significant reductions in diesel emissions in terms of tons of pollution produced and diesel emissions exposure, particularly from fleets operating in areas designated by the Administrator as poor air quality areas. U.S. EPA Accepting Applications for SmartWay Program – Deadline: February 10, 2011

The U.S. EPA's SmartWay Program and National Clean Diesel Campaign are announcing the availability of funding assistance to create finance programs, such as low-cost leases or revolving loan programs, to achieve significant reductions in diesel emissions throughout the United States. The SmartWay Finance Program is soliciting proposals for projects that reduce diesel emissions through the creation of national, tribal, regional, state or local finance program(s). Finance programs include, but are not limited to, those that provide the loan recipient a specific financial incentive (i.e., longer terms or lower rates) to purchase or lease eligible retrofitted vehicles or equipment. The proposed finance program should maximize the total project funds available for financing eligible diesel emission reduction solutions and be sustainable to maintain the program. Eligible entities include regional, state, local, or tribal agencies or port authorities with jurisdiction over transportation or air quality, and certain non-profit organizations and institutions.

U.S. DOT's Transportation Infrastructure and Innovation Act Offers Credit Assistance - Deadline: February 18, 2011 The U.S. DOT's Transportation Infrastructure Finance and Innovation Act Joint Program Office announced the availablity of funding to support new applications for credit assistance. U.S. HUD to Award \$25 Million through New Rural Innovation Fund – Deadline: February 23, 2011

The U.S. Department of Housing and Urban Development (HUD) announced that \$25,750,000 will be available for grants made through the Rural Innovation Fund (RIF). RIF replaces HUD's former Rural Housing and Economic Development Program, and will award grants on a competitive basis to state housing finance agencies, community development corporations, state community and/or economic development agencies, local rural non-profit organizations, federally recognized Indian tribes and consortia of these eligible groups. Successful grant applications will propose new and innovative solutions to poor housing conditions and concentrated poverty in rural and tribal areas. HUD is particularly interested in proposals that incorporate an "entrepreneurial approach" to addressing these problems. Eligible housing and economic development activities include: Commissioning architectural and engineering plans; Construction of innovative new housing units; Demolition and/or rehabilitation of existing housing units to increase sustainability and/or energy efficiency; Land acquisition; Homeownership counseling Revolving loan programs and microlending programs to establish or grow local businesses and create jobs; and, Direct financial assistance in the form of grants, loans and funding for Individual Development Accounts (IDAs) for affordable housing, entrepreneurship and economic development leading to job opportunities. DOL Releases Grant Applications for Trade Adjustment Assistance Community College and Career Training Program - Deadline: April 21, 2011

Last week the U.S. Department of Labor (DOL) Employment and Training

Administration (ETA) announced the release of \$500 million in grant funds for the Trade Adjustment Assistance Community College and Career Training (TAACCCT) program. While applicants must be institutions of higher education eligible for training under the Trade Adjustment Assistance program, regional councils and Workforce Investment Boards (WIBs) have proven to be key partners for similar work undertaken through NARC's *Pathways Out of Poverty* project, also funded by DOL ETA. Projects to expand and improve the delivery of education and career training programs for workers eligible for training under the TAA for Workers program to become employed in high-wage, high-skill occupations will be considered under the TAACCCT program.
