NARC Submits Comments to BLS on a Green Jobs Definition: Last week. NARC submitted comments to The Bureau of Labor Statistics (BLS) on its proposed definition of green jobs. This definition, which includes seven green economic activity categories and four categories for green jobs and services, will be used to measure green jobs activity in the economy. NARC Submits Comments to DOT on Potential Joint DOT-HUD Funding: NARC submitted comments in response to the U.S. Department of Transportation's (DOT) interim notice of funding availability for the Department's National Infrastructure Investment Grant program (TIGER II Discretionary Grant Program). NARC commented on combining the TIGER II Planning Grant Program with the U.S. Department of Housing and Urban Development's (HUD) Community Challenge Planning Grants to better align transportation, housing, economic development and land use planning, and to improve the linkages between the Sustainable Communities Partnership programs, while promoting holistic planning efforts that result in better Federally funded projects. Spill. The costs could outstrip any benefit from recent employment or Stimulus spending gains. Florida Gov. Charlie Crist has asked President Barack Obama for \$50 million in federal assistance for the fallout from the Deepwater Horizon oil spill in the Gulf of Mexico. Crist said this is an, "environmental disaster of unprecedented proportions," and wants the money for extended unemployment benefits that will be needed when the spill throws Floridians out of work. Louisiana Gov. Bobby Jindal last Thursday declared a State of Emergency to begin preparing for the oil. He also requested a federal disaster declaration to aid commercial fisherman, providing funds and potentially suspending loan repayments to the government. The cost to Gulf Coast fishing and tourism industry could be over \$5 billion. We will be addressing long-term disaster recovery planning at our Annual Conference in Cleveland.

Continued Investment Needed in Nation's Infrastructure
Joseph Stiglitz, Nobel Prize winner for economics in 2001, and chief economist at the World Bank during the Asian meltdown of 1997, gained hands-on experience in the disorderly business of financial bailouts. He recently gave a fascinating interview in Money magazine which makes the case for continued investment in our nation's infrastructure. Here's an excerpt from this month's edition:

(Money) Now the President and others are talking about budget cuts. Does that make sense?

(Stiglitz) The key issue is how we spend money. I've done calculations that show that if we borrow money to make investments in infrastructure, technology, and education, the long-term national debt will be lower. If you spend money, and the economy grows, you get more tax revenue.

The draft guidance explains how Federal agencies should analyze the environmental impacts of greenhouse gas emissions and climate change when they describe the environmental impacts of a proposed action under NEPA. USDA Releases Report on Agriculture Transportation: The U.S. Department of Agriculture (USDA) released to Congress a comprehensive report on agricultural transportation in the United States. The report, *Study of Rural Transportation Issues*, was mandated by the 2008 Farm Bill and covers the four major modes of transportation commonly used by agriculture in the United States – truck, rail, barge and ocean vessel. The report examines some of the major issues facing agricultural transportation, including: the effect of rail deregulation, a growing gap for funding the inland waterways and highway systems, availability of containers and ocean vessel capacity and the infrastructure needed to support a projected increase in biofuel transportation. The report also discusses the current approach to transportation policy in the United States, in which each mode of transportation is often considered separately without an overarching view of the flow of freight through all the modes. NARC Supports Rural Regions at U.S. Senate Democratic Rural Summit: Last week, NARC participated in the first Senate Democratic Rural Summit, which focused on the commitment to ensuring a brighter future for the nation's rural communities through infrastructure and access to critical services and building a sustainable rural economy. A diverse cross-section of rural interests attended the meeting and discussed best practices in existing rural programs and policies. The Summit, hosted by Majority Leader Reid (D-NV), Senator Stabenow (D-MI) and Senator Lincoln (D-AR), featured presentations from Senators Begich (D-AK),

(Money) What should we be spending on, then?

(Stiglitz) We need greater investment in high-speed railroads and other public transportation. And we need to invest in technology. We invested very heavily in the '80s in particular -public investments that led to the Internet, to the decoding of the human genome. And because of the public investment, there were huge investments in the private sector that generated huge returns for our economy. We can't know what the next breakthrough will be, but if you're not spending the money, you won't have that breakthrough.

GRANTOPPORTUNITIES

Serving Young Adult Offenders and High School Dropouts: *Deadline: May 10, 2010:* U.S. Department of Labor's (DOL) ETA announced approximately \$20 million for two grants to provide employment services to young adult offenders and high school dropouts ages 18 to 24 in high-poverty, high-crime communities. DOL expects to award two grants of \$10 million each covering a six-month planning period and two full years of operation. Each grantee will be required to competitively select local sub-grantees to operate programs in a minimum of five high-poverty, high-crime communities in at least two different states. USDA Grant to Enhance Market-based Approaches to Conservation: *Deadline: June 4, 2010*. The U.S. Department of Agriculture (USDA) announced the availability of approximately \$25 million to fund projects designed to stimulate the development and adoption of innovative conservation approaches and technologies through its Conservation Innovation Grants (CIG). USDA will use these competitive grants to seek creative solutions to assist producers with emerging and traditional agricultural and natural resource issues. In addition to market-based approaches to conservation, emerging issues include energy conservation, specialty crops, and new methods of tackling climate change. The grants also will fund solutions to improve water, soil and air quality, improve nutrient management, and enhance wildlife habitat and pollinator populations. CIG funds one-to-three year projects that targets innovative on-the-ground conservation, including pilot projects and field demonstrations. The maximum federal contribution for each project is \$1 million. The \$25 million in CIG funding will be divided into three categories:

- National Approximately \$15 million will be available for proposals that address specific CIG resource concerns nationwide such as energy conservation and climate change.
- Mississippi River Basin About \$5 million will be used to address resource concerns in the Mississippi River Basin.
- Chesapeake Bay Watershed Up to \$5 million will be available for proposals that address natural resource concerns in the 64,000 square-mile watershed.

USDA will use a two-phased approach to award CIGs this fiscal year. Those eligible for CIG include federally-recognized Indian tribes, state and local units of governments, non-governmental organizations and individuals. Full applications for selected preproposals must be submitted by June 4, 2010. All CIG projects must include agricultural producers who meet pre-set eligibility requirements. DOE Announcement of Funding Opportunity for Weatherization Innovation Pilot Program: *Deadline: June 2, 2010.* The Department of Energy's (DOE) Office of Energy Efficiency and Renewable Energy (EERE), released a new funding opportunity announcement for up to \$30 million for competitively selected innovative weatherization projects. This Weatherization Innovation Pilot Program promotes innovative ways to weatherize homes of low-income families. DOE anticipates making 10-15 awards. Traditional and non-traditional weatherization providers are eligible to apply including: states and units of local government; non-profit entities such as community development organizations; for-profit entities; institutions of higher education; Indian tribe economic development entities; and, consortia of these entities. EDA Announcement of Funding Opportunity for Public Works Infrastructure Improvements and Planning: Deadline: September 30, 2010. EDA will provide Public Works investments to support the construction or rehabilitation of essential public infrastructure and facilities necessary to generate or retain private sector jobs and investments, attract private sector capital, and promote regional competitiveness, innovation, and entrepreneurship, including investments that expand and upgrade infrastructure to attract new industry, support technology-led development, accelerate new business development, and enhance the ability of regions to capitalize on opportunities presented by free trade. EDA encourages recipients to be sensitive to the energy and environmental implications of their activities. To the extent practicable, and dependent upon the project type and in consideration of the financial resources available, EDA encourages recipients to use the best available strategies, technologies, and construction practices in order to minimize energy use and environmental impacts. Recipients are encouraged to determine the project's consistency with the Climate Action Plan of the State in which the proposed project will be located, if applicable.
