EPA Releases Draft Clean Water Strategy: The U.S. Environmental Protection Agency (EPA) released a draft clean water strategy that outlines plans for new rules and other initiatives to prevent water quality from degrading, better manage pollution from animal feeding operations, expand coverage of municipal stormwater permits and promote green infrastructure. The draft document, Coming Together for Clean Water: EPA's Strategy for Achieving Clean Water, was developed following an EPA forum that included NARC representative Kenneth Fallows, Co-Chair, NARC Environment Committee. Both the House and Senate will return this week from Recess.

NARC and CFED Discuss Economic Development Funding Opportunity: Today, NARC and the **Corporation for Enterprise Development** (CFED) conducted a webinar CFED's efforts to creation of a Federal Home Loan Bank (FHLB) Economic Development Program (EDP) to fund grants or loan guarantees for retail, commercial or industrial facilities that provide quality jobs for those that are unemployed, disadvantaged or earn low wages. EDP funds could also be available for nonprofits focused on economic development activities in disadvantaged communities to hire staff, operate loan funds or provide business assistance. This could be a potential new source of economic development funding for local governments and regional councils to tap into. CFED is working with Congressman Kanjorski (D-PA) and other members of the **House Financial Services Committee**, as well as the Senate Banking, Housing and Urban Affairs Committee to move this concept forward. Congress to Work on Continuing Resolution: This week Congress returns from recess to work on a variety of bills, including a Continuing Resolution (CR), which will keep the government funded after the new fiscal year begins on October 1. Details on what the CR will include have not been released. To date, the House has only passed two of the 12 FY11 appropriations bills – Military Construction-Veterans Affairs and Transportation-HUD; the Senate has not completed any. Congress is targeting October 8 as an adjournment date for campaigning for the upcoming elections. It is possible, if Congress doesn't finish work on the appropriations bills that they will look to enact an omnibus measure after the elections. Click HERE to follow progress and get

Senate to Work on Small Business Legislation: The Senate will return on Tuesday to continue work on legislation for small business assistance, HR 5297, the Small Business Jobs and Credit Act of 2010. The bill, which passed the House in mid-June, would establish a \$30 billion lending fund for small businesses, provide \$12 billion in tax breaks, and enhance federal programs that support small businesses. Support Livable Communities: Both the House (HR 4690) and Senate (S1619) have bills supporting the regional role in building livable communities with their local governments. The legislation seeks to reinvigorate regional comprehensive planning and implementation for regions of all sizes and make ups. We urge all regional planning organizations and their boards of local elected officials to send letters of support to your Congressional delegation urging their endorsement by showcasing the on-the-ground benefits of this legislation for your region. EDA Announces of Funding Opportunity for Public Works Infrastructure Improvements and Planning - Deadline: September 30, 2010

The U.S. Department of Commerce Economic Development Administration (EDA) will provide Public Works investments to support the construction or rehabilitation of essential public infrastructure and facilities necessary to generate or retain private sector jobs and investments, attract private sector capital, and promote regional competitiveness, innovation, and entrepreneurship, including investments that expand and upgrade infrastructure to attract new industry, support technology-led development, accelerate new business development and enhance the ability of regions to capitalize on opportunities presented by free trade. Federal Geographic Data Committee Announces Tentative Schedule for 2011 National Spatial Data Infrastructure Cooperative Agreements

Program – Solicitation to be posted in Mid to Late October 2010

The Federal Geographic Data Committee (FGDC) recently announced its tentative schedule for soliciting and selecting applicants for its 2011 National Spatial Data Infrastructure (NSDI) Cooperative Agreements Program (CAP). Additional information is available HERE on the FGDC website, which will be

updated as the solicitation is posted on **Grants.gov** and deadlines are finalized.

### U.S. EPA Funding Available to Support Brownfields Assessments -

Deadline: October 15, 2010

The U.S. EPA has funding available to support brownfields assessments, including inventories, characterizations, cleanup planning and community involvement related to brownfield sites. EPA anticipates awarding an estimated 185 assessment grants for an estimated \$52.4 million, and a total of \$92.9 million in related Brownfields grants. For community-wide proposals, applicants may request up to \$200,000 for hazardous substances, and up to \$200,000 for petroleum activities. For site specific grants, applicants may request a waiver up to \$350,000 and assessment coalitions may submit a proposal up to \$1,000,000. Interest in sustainable redevelopment of sites. Eligible entities include: local governments, regional councils and tribes. Nonprofits not eligible. Click HERE for more information.

U.S. DOT Funding Available for the Rail Line Relocation and Improvement Projects (Program) - Deadline: October 29, 2010

The Federal Railroad Administration announced the availability of approximately \$20.5 million in discretionary funding for the Rail Line Relocation and Improvement Projects (Program) in a notice published in the Federal Register (see attached). Projects eligible are construction projects undertaken for the improvement of the route or structure of a rail line that either: are carried out for the purpose of mitigating the adverse effects of rail traffic on safety, motor vehicle traffic flow, community quality of life, or economic development; or involve a lateral or vertical relocation of any portion of the rail line. ## U.S. HUD Funding Available through HOPE VI Revitalization grant

program - Deadline: November 22, 2010

HUD is making available approximately \$124 million in assistance through the FY2010 HOPE VI Revitalization grant program for public housing authorities

with severely distressed public housing. The maximum amount of each grant award is \$22 million; it is anticipated that five or six grant awards will be made. Eligible entities are (non-troubled) public housing authorities (PHAs) with severely distressed public housing, subject to the requirements under Section III of this Notice of Funding Availability. Nonprofit organizations, forprofit organizations, private citizens and entrepreneurs are not eligible to apply. Click <u>HERE</u> for more information.
