# Congress Brief

## Congress Unlikely to Repeat Successes of Last Year

Congress returned from the holiday break, fresh off some notable legislative victories like passage of transportation reauthorization (FAST Act) and a massive spending and tax extenders package. There is wide agreement that 2016 will be less robust in terms of legislative victories, largely because the presidential election is about to heat up. This leaves an open question regarding the likelihood of at least one quickly approaching deadline - the Federal Aviation Administration Reauthorization extension, which expires March 31. The end of the fiscal year could also be challenging for spending bills that expire at the end of September. 2016 is likely to see a lot of gridlock and numerous extensions.

# **ADMINISTRATION BRIEF**

#### National Aging and Disability Transportation Center

FTA created the National Aging and Disability Transportation Center (NADTC), a technical assistance center that offers guidance and support to transportation providers, advocacy groups, and individuals. NADTC will help expand travel options and promote the availability of FTA funding that improves mobility for older adults and individuals with disabilities. The center will encourage specialized transportation services that maximize the reach of FTA's **Enhanced Mobility of Seniors and Individuals with Disabilities grant program** and other transit investments.

#### Hurricane Sandy Disaster Relief Dashboard Update

FTA updated the Hurricane Sandy Disaster Relief Dashboard with information reflecting grants

awarded as of September 30, 2015. Several transit authorities and cities received grant money to help with recovery. The Public Transportation Emergency Relief Program helps states and public transportation systems pay for protecting, repairing, and replacing facilities that may have suffered damage during natural disasters.

#### **Climate Change Resilience Pilots**

FHWA, state DOTs, and MPOs assessed transportation vulnerability and options for improving resiliency during the 2013-2015 Climate Change Resilience program. A final report from FHWA will be released this year and the data and experiences will be used to update the *Climate Change & Extreme Weather Vulnerability Assessment Framework*.

## **ODOT recognizes NOACA Transportation for Livable Communities Initiative**

The Ohio Department of Transportation (ODOT) recently recognized the Transportation for Livable Communities Initiative (TLCI) and the Transportation Asset Management Program as a successful Regional Model of Cooperation under the Every Day Counts initiative. The TLCI provides federal funding and technical assistance to help communities improve quality of life and livability. Recently, 19 TLCI grants were awarded by the Northeast Ohio Areawide Coordinating Agency (NOACA) to improve the multimodal transportation system.
