President Calls for More Spending, Regional Planning: In a speech in Minnesota yesterday, President Obama reiterated his support for a longer transportation bill with more spending, calling for a four-year bill worth \$302 billion (B). The speech itself was short on specifics, but the White House separately released a fact sheet that outlined the President's proposal in more detail. The proposal highlights an additional \$63B in funding to shore up the highway trust fund (HTF) – through a one-time transfer of "transition revenue" from "pro-growth business tax reform" – and a focus on "fix it first" projects.

Of the \$302B, the President would provide \$199B for highways and another \$7B for highway and road safety; \$72B for transit systems including light rail, street cars, and bus rapid transit; \$19B for dedicated rail funding, including \$5B for "high performance and passenger rail programs"; and \$9B in competitive funding, including \$5B for *Transportation Investment Generating Economic Recovery* (TIGER) grants and \$4B to "incentivize innovation and local policy reforms to encourage better performance, productivity, and cost-effectiveness in our transportation systems." He would also fund items under his *Ladders of Opportunity* initiative, including dedicated BRT funding for fast growing regions, workforce development opportunities, and a \$10B

dedicated multimodal freight program. There is also a significant section focused on boosting efficiency and increasing return for taxpayers, including improved project delivery, incentivizing resilient communities, and increasing private investment.

The President also gave a nod to regional planning and local decision making. The White House fact sheet states: "The proposal includes policy reforms to incentivize improved regional coordination and strengthen local decision making in allocating Federal funding so that local communities can better realize their vision for improved mobility." It remains to be seen how the President would implement this vision in policy, but it is a sentiment we can appreciate.

President Obama & DOT Secretary Foxx Announce \$600M for Sixth Round of Tiger Funding: Yesterday President Obama announced that \$600 million (M) is being made available by the U.S. Department of Transportation (DOT) to fund transportation projects. The funding will be made through the TIGER Discretionary Grant Program for road, rail, transit, and port projects. "President Obama knows that transportation means opportunity for so many Americans," said Foxx. "TIGER investments answer the President's challenge to expand opportunity through a strong transportation system that connects Americans with a better way of life." The 2014 TIGER program will place an emphasis on projects that connect people to jobs and schools, promote neighborhood revitalization and business expansion, and reconnect neighborhoods that are divided by physical barriers like highways and railroads.

Do They Have the Ways and Means? The U.S. House Ways and Means Committee Chairman David Camp (R-MI) this week released an outline of broad based tax reform that would – among many other things – dedicate \$126.5B to the nation's HTF, enough to provide for an eight year reauthorization. While this is a positive step, this amount would not

be an increase in current funding, but merely make up the gap between gas tax collections and current spending levels, which many believe represent an inadequate level of investment in the nation's infrastructure. More details of Camp's proposal are **HERE**.

DC: Metro Hails Funding Commitment by Gov. O'Malley, Gov. McAuliffe, and Mayor Gray: Metro General Manager and CEO Richard Sarles on February 26 applauded an increased capital commitment of \$75M by Maryland Gov. Martin O'Malley, Virginia Gov. Terry McAuliffe, and District of Columbia Mayor Vincent C. Gray, saying that it marked an important down payment toward Metro's *Momentum* strategic plan to reduce crowding and add system capacity. The plan addresses growing crowding and outlines near-term goals for 2025, along with the steps that Metro must take to prepare for coming regional population and economic growth. The plan ensures that Metro never returns to a time when the system's tracks, escalators, trains, and buses are not maintained to today's safety and reliability standards. For riders, *Momentum* will mean more trains; reduced crowding; faster buses; brighter, safer, easier-to-navigate Metrorail stations; and improved customer information systems.
