ADMINISTRATION BRIEF

FHWA Bicycle-Pedestrian Count Technology Pilot Program

In an effort to support data-driven community planning and investment decisions, FHWA will provide grants to ten MPOs to purchase counting equipment to collect better bicycle and pedestrian activity data. The ten MPOs participating in FHWA's Bicycle-Pedestrian Count Technology Pilot Program will also receive technical support in counting activities. Lessons learned will be available to the public upon completion of the pilot program early next year.

Foxx Announces Ladders of Opportunity Pilot

USDOT's Ladders of Opportunity Program examines the transportation infrastructure choices made at the federal, state, and local levels and how they can impact community vitality and create employment opportunities. Secretary Foxx announced the launch of a Ladders of Opportunity Empowerment Pilot Program called **LadderStep**, which will provide **technical assistance** to seven cities to help them foster sustainable economic development through transportation projects.

NIST Draft Community Resilience Guide: Feedback Needed

The National Institute of Standards and Technology (NIST) released a draft of its *Community Resilience Planning Guide for Buildings and Infrastructure*, a tool designed to lead communities through a step-by-step action process to keep natural and industrial mishaps and hazards from inflicting disastrous consequences, and to ensure that buildings and infrastructure systems can support social needs especially during disaster recovery. NIST requests **public feedback** through June 27 on the draft guide. They anticipate releasing the official guide in the fall.

Congress Brief

Short-Term Funding Extension Likely

In the first acknowledgement by House leaders that Congress will not meet the May deadline for a long-term transportation bill, House Majority Leader Kevin McCarthy told reporters this week that Congress would likely pass a short-term extension of the program. McCarthy suggests that a short-term extension would give Congress more time to find funding for the program when the current funding expires. USDOT warned that it will reduce reimbursements for transportation programs as early as June if Congress does not specify new funding for the program. For the past several years, transportation tax revenue flowing into the highway trust fund is \$13 billion less than actual federal transportation spending, requiring Congress to supplement the program. If Congress does not want to use Treasury funds to make up the different between tax revenues and expenditures, they will need to find another source of funds to continue transportation spending at current levels

or impose major cuts, as threatened by USDOT.

House Appropriations Released THUD Bill

The House Committee on Appropriations released the FY 2016 Transportation, Housing, and Urban Development (THUD) funding bill, which includes funding for USDOT. The bill allocates a total of \$55.3 billion in discretionary funds to USDOT, the U. S. Department of Housing and Urban Development, and related agencies, which represents a \$25 million increase from current spending. While the Federal Aviation Administration, the Maritime Administration (MARAD), and various transportation safety programs throughout USDOT would benefit from an increase in funding allocation set forth in this bill, other grant programs and agencies like the Federal Railroad Administration and FTA would suffer a severe cut in allocated funding compared to FY 2015. House THUD Subcommittee Chairman Mario Diaz-Balart (R-FL) explained the decreases in allocations as "cutting wasteful programs" and supporting "critical infrastructure and housing needs by focusing on core operations."

Birmingham to Launch Electric-Assist Bike Share

The Regional Planning Commission of Greater Birmingham announced the launch of the city's first bike share this fall, with a quarter of the 400-count bicycle fleet using electric-assist technology. The electricity provides pedaling assistance in hilly terrain, mainly outside of the downtown area. Birmingham was able to initiate the program with a \$2 million Congestion Mitigation and Air Quality (CMAQ) federal grant.
