# Congress Brief

### **Senate EPW Markup Next Week**

On Wednesday, the Senate Environment and Public Work Committee is scheduled to mark-up a long-term transportation reauthorization bill. Though language has not been released, initial indications from staff indicate the bill will provide six years of funding and an increase relative to current funding levels, mainly tied to inflationary growth. NARC will share a complete analysis of the bill shortly after language is released early next week.

### **House and Senate Hold Funding Hearings**

On consecutive days this week, the **House Ways and Means Committee** and **Senate Finance Committee** held hearings to explore long-term funding solutions for the nation's Highway Trust Fund (HTF). Additional funding is required because the primary source of receipts, the federal fuel tax, collects billions of dollars less than current spending. House Ways and Means Chairman Paul Ryan (R-WI) stated unequivocally his belief that a gas tax increase is entirely off the table, though the witnesses felt the gas tax remains the best vehicle for increased funding. Senate Finance Committee Chairman Orrin Hatch (R-UT) was nearly as resolute, but did leave a small door open that could allow for the possibility of a gas tax increase. Otherwise, the conversation at both hearings offered little in the way of new ideas, and mostly centered on how to offset a massive transfer from the General Fund into the HTF, with the idea of taxing off-shore corporate holdings (repatriation) as a popular contender.

#### **Shuster Reveals Proposal for FAA Reform**

House Transportation and Infrastructure Committee Chairman Bill Shuster (R-PA) revealed in a **speech** to the Aero Club of Washington that his committee is drafting an Aviation Reauthorization bill that would reform the US air-traffic control (ATC) system and the Federal Aviation Administration's (FAA) technology certification process. In his outline of **principles** for aviation reform, Shuster proposes to privatize the ATC system by granting operation authority to an independent non-profit organization. The FAA would retain safety oversight and a board of aviation system users would be established to govern the new non-profit and ensure representation of the public interest. Shuster also proposes to streamline the FAA certification processes for aircraft and equipment, which he believes is the key to keeping the US innovative and globally competitive in transporting passengers and freight.

# **ADMINISTRATION BRIEF**

### Complete Streets Survey for States and Regions due June 19

The National Cooperative Highway Research Program (NCHRP) requests that states and regions provide information on the status of Complete Streets implementation. In cooperation with FHWA, the NCHRP is administered by the Transportation Research Board and sponsored by members of the American Association of State Highway and Transportation Officials (AASHTO). NCHRP asks that participants take 10 minutes to complete their sixth survey in the Snapshot of Planning Practices series. Insights gained through the survey will be aggregated and published quarterly in a

### Metro Atlanta Toilet Rebate Program

The Metropolitan North Georgia Water Planning District began a **toilet retrofit program** in 2008 to replace inefficient toilets with low-flow WaterSense toilet models in homes built in 1993 or earlier. Because the water-saving effort is ongoing, customers of local water utilities participating in the program are still able to apply for toilet rebates. The program has replaced over 100,000 toilets, saving an estimated 900 million gallons of water per year and reducing water use in the Atlanta metro area by 10% - even with a population increase.

This third webinar in the series will focus on the sustainability implications of concrete paving materials, aggregates, design and construction considerations, and emerging trends.
