NEWS FROM WASHINGTON

Congress is in session.

Overview

The National Governors Association and National Association of Counties conferences are taking place this week and Congress is in session, so lots of legislators are in DC right now.

While the presidential election primaries and discussion over a successor to Supreme Court Justice Antonin Scalia are in full swing, Congress will begin hearings on the 2017 appropriations debate this week. Committees in both the House and Senate have scheduled hearings on individual spending bills with cabinet secretaries and agency heads to justify the Administration's budget request. Despite last year's budget agreement that kept spending at current levels for most programs important to NARC and local governments, the intense battle over the Supreme Court opening combined with the anger over Speaker Ryan's first budget negotiations with the White House should jettison any chance for a typical appropriations debate.

The Congressional Budget Office reported that the federal deficit will soar over the next decade if we keep pace with current spending levels without finding additional revenue. Then today, *Congressional Quarterly* reported that House Republicans reached agreement over the weekend on a budget resolution with deep spending cuts. All of these factors make another partisan battle over spending a very likely concern, potentially jeopardizing 2017 funding for local programs like community development block grants, transit, and public safety.

Up In The Air

One of the major issues in the upcoming Federal Aviation Administration (FAA) reauthorization is the regulation of drones. As part of the integration of drones into the system, Congress is looking to provide more of a framework for drones in the FAA authorization. Additionally, FAA will be releasing small-drone regulations this year. Still, there are many unanswered questions regarding public safety and personal rights in the use of drones. Drones are especially useful for inspection of infrastructure, monitoring crops, and transporting medical supplies but they are also used for recreation and potentially package delivery. This crossover of personal and commercial use creates a difficult regulation task. A framework of regulations will need to be developed intelligently and quickly to integrate unmanned aircrafts into the system starting with FAA's reauthorization.
