NEWS FROM WASHINGTON

Congress is in session.

Overview

Both the House and Senate are in session this week. The Senate will work on an anti-opioid bill and the House will consider a bill to reauthorize FEMA assistance programs. Hearings on federal spending programs will continue this week.

The Senate will respond to the dramatic rise in prescription drug and heroin abuse with consideration of the *Comprehensive Addiction and Recovery Act of 2016 (S 524)* to expand efforts to curb drug abuse, increase access to medication that can reverse overdoses and establish a treatment and intervention program. The bill, sponsored by Senators Sheldon Whitehouse (D-RI) and Rob Portman (R-OH), would also provide incentives for states to track at-risk individuals.

The House will consider the *FEMA Disaster Assistance Reform Act of 2015 (HR 1471)*, which aims to extend FEMA disaster programs through FY2018 and authorize funding for key local government programs. The bill would reauthorize FEMA and the National Urban Service and Rescue Response System, clarifying compensation and liability for responders. The measure includes provisions intended to reduce future losses from disasters, improve the recovery process for victims and affected communities, raise the amount of FEMA disaster relief funding provided to victims under simplified procedures, block the ability of FEMA to reclaim certain payments after three years, and allow FEMA to waive certain debts caused by FEMA errors. The legislation requires FEMA to undertake efforts to prepare for and protect the nation from earthquakes, tsunamis, and their combined effects. It also calls for a study to determine why disaster costs continue to increase. The \$947 million bill passed the House Transportation and Infrastructure Committee last April and is just now coming to the floor for consideration.

Cities, Counties Announce Joint Task Force on the Opioid Epidemic

With the opioid and heroin abuse crisis reaching epidemic proportions, the National League of Cities (NLC) and National Association of Counties (NACo) have joined together to address the problem. Drug overdose is now the leading cause of accidental death in the U.S., with more than 47,000 lethal drug overdoses in 2014 driven largely by overdose deaths related to prescription pain relievers (18,893) and deaths related to heroin (10,574). There were 259 million opioid prescriptions written in 2012, which is more than enough to give a pill bottle to every American adult.

Last week, NLC and NACo announced the creation of a joint national task force to address this crisis by enhancing awareness, facilitating peer exchanges, and identifying sound policy and partnership solutions. The task force will build upon the **White House Office of National Drug Control Policy's four-pillared plan** to reduce prescription drug abuse.

NACo Testifies on Improving Unfunded Mandates Reform Act

Last week, NACo First Vice President Bryan Desloge testified before the U.S. Senate Homeland Security and Governmental Affairs' Subcommittee on Regulatory Affairs and Federal Management. Desloge, a commissioner in Leon County, FL, **made the case** for improving the federal government's process for evaluating and reducing the harmful impacts of federal mandates on counties and residents.

Final WIOA Unified and Combined State Plan Requirements Available

States must use the Information Collection Request (ICR) for the *Workforce Innovation and Opportunity Act (WIOA) Unified and Combined State Plans Requirements*. The Office of Management and Budget (OMB) reviewed and approved this data collection (Control Number 1205-0222). These documents reflect the incorporation of public comments received from the publication of the August 6 Federal Register notice prepared by the U.S. Departments of Labor, Education, Housing and Urban Development, Health and Human Services, and Agriculture.

Smart Cities Challenge to be Announced March 12

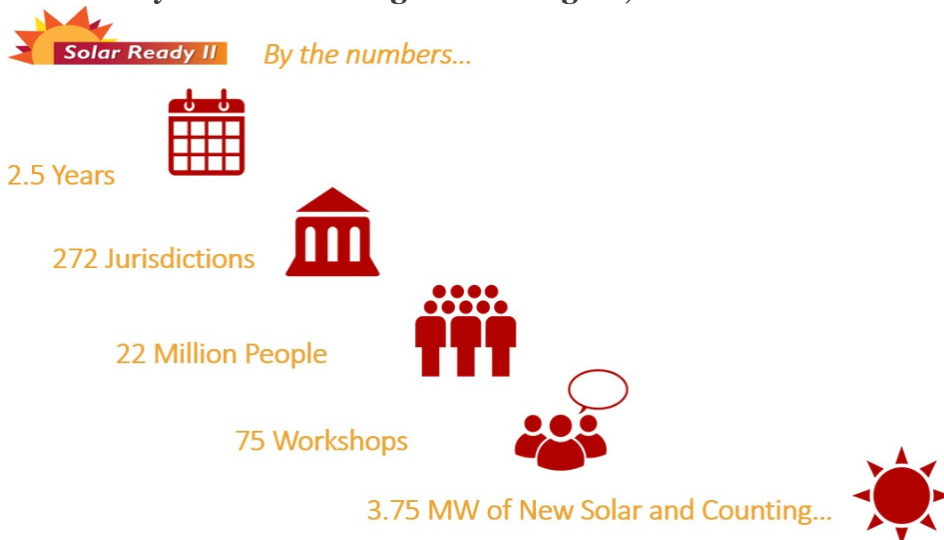

Solar Ready II Team Meeting in Washington, DC



Last week, nine regional councils on the Solar Ready II team and representatives from the U.S. Department of Energy (DOE) and Meister Consultants Group convened in Washington, D.C. at NARC and the Metropolitan Washington Council of Governments' offices for a final all team meeting. The Solar Ready II project, funded by the U.S. Department of Energy SunShot Initiative Rooftop Solar Challenge II, began in October 2013 and will conclude next month. During the meeting, attendees discussed the outcomes and accomplishments, and strategized ways to keep the momentum going after the project ends. Over the last 30 months, the regional councils have become valuable solar resources to their member local governments. These are unique

opportunities for local governments to receive tailored guidance on solar best practices, which otherwise would not occur if it was not for the regional council's newly formed role and presence as a solar advocate in the community. Together, the Solar Ready II team has increased over 270 local governments' understanding of the current solar market in the area and explained the steps they can take to improve their current solar processes and policies. FY2015 SAFER Application Period Open

Deadline: March 25, 5:00 PM ET

The Fiscal Year (FY) 2015 Staffing for Adequate Fire and Emergency Response (SAFER) application period is open. SAFER intends to improve or restore local fire departments' staffing and deployment capabilities so they may more effectively and safely respond to emergencies. With enhanced or restored staffing levels, recipients should experience a reduction in response times and an increase in the number of trained personnel assembled at the incident scene. The SAFER program is comprised of two activities, the Hiring Activity and the Recruitment and Retention of Volunteer Firefighters Activity. The objective of the Hiring Activity is to award grants directly to volunteer, combination, and career fire departments to help increase the number of frontline firefighters and to rehire firefighters who were laid-off due to the economy. The objective of the Recruitment and Retention of Volunteer Firefighters Activity is to create a more favorable working environment for volunteer firefighters.

HUD Housing Counseling Grants

Deadline: April 4

The U.S. Department of Housing and Urban Development (HUD) announced \$40 million in funding to support hundreds of housing counseling organizations across the country that assist families, including those buying their first home, struggling to locate affordable rental housing or seeking to avoid foreclosure. It is estimated HUD's housing counseling grants and the additional funding they leverage will reach more than 1.5 million households through a network of approximately 300 national, regional and local organizations. TIGER Discretionary Grants

Deadline: April 29

Transportation Secretary Foxx announced the eighth round of the TIGER discretionary grant program, worth \$500 million. These grants fund surface transportation projects on a competitive basis that have a significant impact on the nation, metro area, or region.
