## USDA Releases Report Highlighting the Importance of Regional

Food Hubs: Last week the USDA Deputy Secretary
Kathleen Merrigan announced a report detailing a comprehensive
evaluation of the economic value and future role of the nation's food
hubs. Highlighting the agency's support of local food
initiatives Merrigan stated, "At USDA we are committed to food hubs
because we believe that they offer strong and sound infrastructure
support to producers across the country which will also help build
stronger regional food systems." The full report titled *The Role of*Food Hubs in Local Food Marketing is available HERE.

**USDA Proposes Updated Definition of "Rural"**: In a report submitted to the House Ag Committee late last month, the USDA proposed updating the definition of "rural area" eligible for support through the agency's rural development programs.

The proposed update would codify a rural area as any population anywhere under 50,000, which would expand eligibility to some locations not previously qualifying for support. Ag committee leaders expressed concern that an expanded definition will shift support from smallest rural communities. The full report is available **HERE**.

Sequester Update: Sequester went into effect on Friday, March 1.

Click <u>HERE</u> to access NARC's summary of sequestration reductions and implementation as issued by the White House Office of Management and Budget (OMB). In Congress, efforts are underway to either repeal or blunt the effects of sequester:

- A group of House Democrats, led by Rep. Conyers (D-MI), introduced the "Cancel the Sequester Act of 2013" to repeal it in its entirety.
- Rep. Issa (R-CA) sent a request to federal agencies to

- identify unnecessary or wasteful programs within their agency that could be eliminated as an alternative to the spending cuts mandated by sequestration. Click **HERE** for more information.
- Republican leaders have indicated interest in a possible deal to lower the deficit, overhaul the tax code and rein in spending on entitlement programs.

Continuing Resolution Update: Today the House introduced HR 933, a continuing resolution (CR) to maintain government funding through the remainder of fiscal year 2013. The bill does not include a fix for sequestration. However, it does include full-year Defense and Military/Construction/Veterans Appropriations bills, restoring \$7 billion and providing more latitude to shift money among defense programs. All other programs in the bill are funded at FY12 levels and are subject to sequestration. It is anticipated that the House will pass the bill later this week with the Senate planning to take it up next week. It is possible that Senate Democrats may push to give other domestic agencies flexibility for sequester. The current CR expires on March 27. Click HERE for a summary and text of HR 933.

House Committee to Markup SKILLS Act: On Wednesday the House Education and Workforce Committee will markup the Republican proposal to reauthorize the Workforce Investment Act. The proposal would consolidate 35 existing workforce, education and training programs into a single \$6 billion Workforce Investment Fund to serve as a single source of support for program participants. The bill text is available <a href="HERE">HERE</a>. The Committee held a <a href="hearing">hearing</a> last week on the legislation. Additional information is available <a href="HERE">HERE</a>.
