### News from Washington

Congress is in session.

#### This Week

Lawmakers return to Washington with eyes on appropriations, which need to be reconciled by April 28 to fund government operations through the rest of the fiscal year. Pressure is on leadership to avoid a politically risky government shutdown, which coincides with Trump's 100th day in office on April 29. How to handle the White House request for \$33 billion in additional funds for defense and border security (including funding for the border wall) is just one of a number of issues that Congress faces in this spending package. If lawmakers can't negotiate a spending package, Congress may pass a one- or two-week stopgap spending measure to prevent a shutdown.

A stopgap bill will keep current spending levels in place, avoiding the major cuts proposed by the president that would eliminate or make major cuts to key local programs, such as the entire U.S. Economic Development Administration; Community Development Block Grants; funding for water infrastructure, transit, Amtrak passenger rail; USDOT's TIGER grants; and human services programs.

Meanwhile, House Republicans may take another stab at repealing Obamacare. House leaders pulled their original legislation in March when it became clear that it wouldn't pass. Since then, lawmakers and the White House have been working to negotiate a compromise. Tomorrow House Republicans have a conference call to discuss repeal efforts and spending legislation. On the agenda is an amendment by Thomas MacArthur (R-NJ) to allow insurers to charge higher premiums to people with pre-existing conditions in states that get a waiver. Other measures the House will be considering this week include: Fannie Mae and Freddie Mac records requests; replacement of the Dodd-Frank Act; nuclear waste storage at Nevada's Yucca Mountain; and the MPO Coordination Rule.

The Senate resumes efforts to confirm President Trump's nominees for administration posts, including a confirmation vote for former Georgia Governor Sonny Perdue to head the U.S. Department of Agriculture. The chamber also plans a cloture vote on the nomination of Rod Rosenstein to be deputy attorney general. The Senate Health, Education, Labor, and Pensions Committee plans a Wednesday vote on the nomination of Scott Gottlieb to lead the U.S. Food and Drug Administration (FDA). And on Thursday, a Special Committee on Aging will hold a hearing, **Aging Without Community: The Consequences of Isolation and Loneliness**.

According to Treasury Secretary Steven Mnuchin, the Trump administration is aiming to complete the biggest tax code overhaul since President Reagan by the end of the year, even if a second attempt to repeal Obamacare fails.

There is little time left to enact *Congressional Review Act* resolutions to negate government regulations published last year. One of the resolutions awaiting action (H.J. Res 36) would overturn Bureau of Land Management rules that require operators of gas and oil wells on federal land to use advanced technology to reduce the venting and burning of methane gas.

### **Support for Park Funding**

In a recent bipartisan letter to the House Interior-Environmental Appropriations Subcommittee over 200 members called for healthy funding for the Land and Water Conservation Fund in fiscal year 2018. Mike Thompson (D-CA) and Patrick Meehan (R-PA) led the letter supporting the fund that Interior Secretary Ryan Zinke committed to making permanent during his confirmation hearing. The last Congress had two bills to permanently reauthorize the Land Water Conservation Fund that had 212 sponsors in the House and 19 sponsors in the Senate.

### **Trump Supports Dem Buy America Bill**

Last week President Trump expressed support for a bill that would increase requirements to buy American. The bill, sponsored by Tammy Baldwin (D-WI), would require American iron or steel for certain drinking-water projects. A similar provision was in the waterways bill last year, but was removed by House Speaker Paul Ryan (R-WI). Trump said, "I agree with her 100 percent" when asked about the bill after signing his Buy American, Hire American executive order.

The goal of this five-year project is to build upon proven models and approaches that can be used by states and communities across the country to involve people with disabilities and older adults in the design and implementation of coordinated transportation systems in ways that successfully make those systems responsive to the needs of these populations.

# Leading Economically Competitive and Resilient Communities Training Program See full list of locations and dates

The Delta Regional Authority presents a series of intensive two-day courses focused on economic development and disaster resiliency strategies to enhance the effectiveness of local elected officials, economic development practitioners, and other community leaders in the Delta region. The workshops are held in partnership with the International Economic Development Council (IEDC) and the U.S. Department of Commerce Economic Development Administration (EDA).

Each workshop will consist of a two-day training that covers one of the following courses – Module A: Basic Economic Development Strategies, Module B: Economic Resilience and Disaster Recovery, or Module C: Advanced Economic Development Strategies. The courses require no prerequisites, and participants are encouraged to attend any of the training workshops offered.

### Public Property / Public Need: Using Vacant Federal Property to End Homelessness April 25, 2:00 PM ET

On April 25, the National Law Center on Homelessness & Poverty (NLCHP) will release Public Property / Public Need: a Toolkit for Using Vacant Federal Property to End Homelessness, and host an accompanying webinar, designed to help local governments and non-profit agencies obtain unused federal land and real property for free under Title V of the McKinney-Vento Homeless Assistance Act. Under federal law, local governments and non-profits have a right of first refusal to property that is no longer needed by the federal government. Moreover, these properties will be conveyed by deed or lease to successful applicants for free. To date, approximately 500 buildings and nearly 900 acres of land have been transferred to organizations serving homeless people in over 30 states to provide a wide array of services, including emergency shelter,

housing, medical care, job training, food, and other services to over 2 million people each year. The toolkit will be available on the NLCHP **website**.

# Federal Reserve Connecting Communities Webinar: Experiences and Perspectives of Young Workers

Young workers in the U.S. experience higher rates of unemployment than the population as a whole. Nonetheless, they are generally optimistic about their job prospects, according to the Federal Reserve Board's new report, *Experiences and Perspectives of Young Workers*. The report, which presents data collected through a 2015 survey, provides a snapshot of the educational attainment, employment experience, job market outlook and financial self-sufficiency of 18- to 30-year-olds. A Resilient Community is one that is prepared for and can adapt to changing conditions and can withstand and recover rapidly from disruptions to its physical and social infrastructure. Modeling community resilience comprehensively requires a concerted effort by experts in engineering social sciences and information sciences to explain how physical, economic, and social infrastructure systems within a real community interact and affect recover efforts. Join this webinar to learn more about the NIST-funded Center for Risk-Based Community Resilience Planning's recent activities. Presentations on the first validation study, The Joplin Hindcast, and the Center's First Field Study, The Lumberton, NC Floods of 2016, will also be highlighted.
