# News from Washington

Senate is in session; House resumes business tomorrow.

#### Overview

After promising a return to regular order and the adoption of regular spending bills rather than an end of the year omnibus, lawmakers stall again. It has been more than 20 years since Congress passed each individual spending bill funding the federal government. With the heightened political sensitivity of an election year and the shortened legislative session, Congress could be looking at another last minute omnibus agreement at the end of September heading into the 2016 Presidential election.

### Senate Tries Again to Pass a Energy-Water Bill

Senate will meet to consider the 2017 Energy and Water Appropriations bill. After two unsuccessful attempts, the Senate will take another pass at voting on the \$37.5 billion funding bill due to controversial amendments.

### **Brownfields Legislation**

On April 25, the Senate passed a brownfields reauthorization bill as part of the Senate Energy bill (S.2012). In the House, two committees have jurisdiction over the program and have held hearings on it, but have not yet introduced legislation. The letter calls on the House Energy and Commerce Committee and House Transportation and Infrastructure Committee to address local government liability, a barrier to the redevelopment of contaminated properties in a proposed brownfields reauthorization bill.

NARC joined the U.S. Conference of Mayors, National Association of Counties (NACo), and National League of Cities (NLC) in a **letter** urging two House panels to act on legislation reauthorizing federal brownfields programs. In the past several weeks, Congress began to move on the U.S. Environmental Protection Agency (EPA) program, last authorized in 2002. NARC met with House committee staff with the goal of writing and introducing a bill in this session of Congress. We encourage you to let your Members of Congress know what this program means to your community.

#### New Study Finds that Rural Broadband Holds Economic Benefits for All

A new report from the Hudson Institute entitled, *The Economic Impact of Rural Broadband*, shows that more widespread access to broadband service in smaller, rural communities has significant economic benefits for both rural and urban areas. The study finds that economic benefits are dispersed more heavily towards urban areas, with two-thirds of the \$24.2 billion final economic demand generated by rural telecom companies and 54 percent of the 69,600 jobs going to urban areas. The report also looks at the federal role of broadband expansion and other quality of life benefits from expanding broadband.

Approximately 40 percent of all trips in the U.S. are less than two miles, making bicycling a feasible and fun way to get to work. With increased interest in healthy, sustainable, and economic transportation options, it's not surprising that, from 2000 to 2013, the number of bicycle commuters in the U.S. grew by more than 62 percent. Established in 1956, National Bike Month is a chance to showcase the many benefits of bicycling — and encourage more folks to give biking a try. **This year**, **Bike to Work Week will be May 16-20**, **with Bike to Work Day on May 20**. We are looking for other regional organizations that have attempted or completed something similar.

**Anonymous:** A joint COG/MPO in a major metropolitan region seeks feedback. Their region's major city has threatened to pull out of the COG, though by federal law would be required to continue participating in the MPO. The dues paid by the city in question are joint COG/MPO dues, with no separation by function. The COG in question would like to know:

- 1. Have other organizations faced a similar threat or situation in their region?
- 2. If you are a COG that also has an MPO, do your members pay separate dues for each?

This would seem to be a unique and possible unprecedented situation, so any perspective other members could offer would be greatly appreciated.

# FEMA Webinars on Proposed Building Standards When Using Public Assistance Funds

May 10, 3:00 - 4:00 PM ET May 12, 2:00 - 3:00 PM ET

Join the Federal Emergency Management Agency (FEMA) for two webinars to discuss proposed policy requiring new minimum building standards in hazard-prone areas. FEMA officials will explain the proposed policy and answer questions from participants. The proposed policy requires that, as a minimum, International Building Code standards be used for construction projects when Public Assistance funding is used. Costs associated with these standards would be eligible. The policy's purpose is to establish minimum standards for Public Assistance projects to promote resiliency and increase achieved risk reduction from future disasters. The draft language is posted to the **Federal Register** and will be available for comment until May 23, 2016.
