authorization bill. With the text rumored for release in the next 24 hours, Environment and Public Works Committee (EPW) leaders have already announced agreement on:

- Passing a long-term measure, not a short-term fix;
- · Keeping formulas for current core programs;
- Exhibiting fiscal responsibility by keeping with current funding levels (plus inflation);
- Focusing on policies that expand transportation opportunities for rural areas;
- Continuing efforts to leverage local resources in order to speed up transportation construction, create jobs, and support economic growth; and
- Requiring "better information sharing" regarding federal grants.

EPW is scheduled to mark up the bill this Thursday, May 15 at 10 a.m. Click HERE for more information on the hearing. Once information is available, NARC will assemble a comprehensive summary of MPO provisions (click HERE for the GROW America Act summary), issue a statement on behalf of the membership, and re-communicate our priorities, ideas and changes with EPW and other Senate offices. Please send us your reactions, congressional correspondence and related commentary. We look forward to continuing outreach, collaboration and advocacy for and with our Board, members and partners.

These topics are perfectly timed as we head into our Annual Conference next month. These and other critical infrastructure issues will take center stage for discussion, keynote addresses and peer networking. We hope to use this time to refine NARC's solutions and responses. PROGRAMUPDATE

The National Climate Assessment: On Tuesday May 6, the White House hosted a stakeholder event featuring speakers from the Administration and authors of the *Third National Climate*

Assessment report released this week. During the event, the speakers asserted that every American will find something in the National Climate Assessment that matters to them. The report summarizes the impacts of climate change on the U.S. today and in the future. Specifically, it explores how climate change will impact eight distinct regions in the U.S. in a variety of ways. It also focuses on how climate change will affect crucial economic sectors like water management, transportation, agriculture, human health, energy, and land use. It also provides a range of strategies that can be taken at the local, state, and federal level to implement cost-effective plans for the looming impacts of climate change. EPA Releases EnviroAtlas Ecosystem Mapping Tool: Last week, the U.S. Environmental Protection Agency (EPA) released EnviroAtlas, a web-based interactive tool that helps decision makers understand the implications of planning and policy decisions on our fragile ecosystems and the communities who depend on services from these ecosystems. EnviroAtlas allows users to visualize and analyze how decisions impact ecosystems and their ability to provide goods and services through data, maps, information, and tools.

POLICYUPDATE

The Senate is in session; the House is in recess.

Appropriations Update: Last week, the U.S. House of Representatives Appropriations Committee approved the 302(b) allocations for the 12 annual appropriations bills. These allocations set the top-line discretionary spending limits for fiscal year (FY) 2015 appropriations, which will remain level for most federal programs. The allocations adhere to the overall \$1.014 trillion discretionary top line codified as part of the December budget deal, as well as separate defense and non-defense spending caps of \$521.3 billion and \$492.4 billion, respectively. The Committee also advanced its FY15 Commerce-Justice-Science appropriations bill, providing \$51.2 billion in discretionary funding, a \$398 million reduction from FY14 enacted levels. For the Economic Development Administration (EDA), the Committee provides \$247.5 million, \$1 million above FY14 and \$682,000 below the President's request. Of that funding, \$210.5 million will be for EDA programs (\$1 million above FY14, \$500,000 above request) and is broken out as follows:

Water Resources Bill Agreement: Last week, the lead conferees from both the U.S. House and the U.S. Senate announced agreement for moving forward the *Water Resources Reform and Development Act* authorization, HR 3080. This week the conference report paperwork will be filed and final votes in both Chambers can occur. Full details on the final legislation will not be released until the conference report is filed.

Amendment Offered to Senate Energy Legislation for New Grant Program: Last week, Sen. Tom Udall (D-NM) filed an amendment to S.2262, the Energy Savings and Industrial Competitiveness Act, which will create a pilot program within the U.S. Department of Energy (DOE) to provide grants to encourage energy efficiency of water facilities, saving both energy and water. If the amendment is agreed to, DOE would award competitive, merit-reviewed grants to three to five water authorities, utilities, municipalities, or water districts for innovative, technology-based projects that increase energy efficiency, conserve water, and support advanced automated systems that provide real-time data on energy and water. The amendment authorizes \$7.5M for the program, to be funded through reallocation of unobligated resources intended to carry out energy efficiency and renewable energy activities. Science, and Transportation: U.S. Secretary of Transportation
Anthony Foxx gave testimony regarding the reauthorization of surface transportation programs and the Administration's recently released surface transportation reauthorization proposal, the *GROW AMERICA Act*. Secretary Foxx began by stressing the urgency of this year's transportation reauthorization, given the looming highway trust fund (HTF) shortfall. He indicated that the highway account will not make it

through the summer; the transit account will be insolvent by October. Without a solution, Foxx indicated that transportation projects will have to be slowed or stopped. In regard to the reauthorization proposal, Foxx remarked that it would increase overall investment and system safety, improve freight and project delivery, and better connect communities. Senate Finance Committee Considers Transportation Funding Options: The Senate Finance Committee last week held a hearing to consider how to fund the nation's highway and transit systems in future years. This conversation is especially important because the HTF is facing insolvency and has too few deposits from fuel taxes to cover current spending levels. Perhaps most striking was the testimony delivered by Dr. Joseph Kile, Assistant Director for Microeconomic Studies Division at the Congressional Budget Office, who spelled out in stark terms the options facing Congress over the next decade:

- Reduce spending to match expected gas tax receipts. This
 would require NO new obligations for one year to allow the
 HTF accounts to "catch up," after which spending from the
 highway account would be cut 30% and from the transit
 account by 65%.
- Increase revenue. Other options exist, but the most likely a
 gas tax increase would have to be 10 to 15 cents per gallon
 to maintain current spending.
- Continue to transfer funds from the Treasury. As it has done for several years now, Congress would have to transfer \$18 billion in fiscal year 2015 and \$13-18 billion each year after to keep the HTF solvent.

House Appropriations Subcommittee Passes \$52 Billion

Transportation and Housing Spending Bill: The transportation,
housing and urban development bill passed the House Appropriations
subcommittee last week. The bill cuts *Transportation Investment*Generating Economic Recovery (TIGER) competitive grants by \$500
million to \$100 million and reduces the list of qualifying projects; cuts
deeply the Essential Air Service Program; and reduces overall

resources for transportation by approximately \$1.1 billion. Click <u>HERE</u> for additional information about the bill.

U.S. Department of Agriculture (USDA) announced \$78 million in funding for local and regional food systems including: food hubs, farmers markets, aggregation and processing facilities, distribution services, and other local food business enterprises. \$30 million of this funding is available through competitive grants via the Agricultural Marketing Service's (AMS) Farmers Market and Local Foods Promotion Program.

EPA - Technical Assistance Funding for Communities Interested in Integrated Planning

Letters of Interest Deadline: June 27, 5:00 PM ET

The U.S. EPA Office of Wastewater Management is accepting letters of interest from communities seeking technical support to develop and implement an integrated planning approach to meeting Clean Water Act requirements for municipal wastewater and stormwater management. The value of the total EPA assistance available in 2014 is approximately \$335,000, and EPA anticipates providing assistance to five communities. Each applicant may submit only one letter of interest, and applicants may apply for project periods of up to nine months.
