#### **Senators Discussing Sequestration Impact with Defense**

**Companies**: A bipartisan group of Senators are requesting 15 defense companies detail the anticipated impact of the pending sequestration on their companies. Click **HERE** to access the letter.

FY13 Appropriations Update: Congress continues to work on the FY13 appropriations bills. The House has passed six of the 12 spending bills and the Senate has not taken any bills to the floor. Very little legislative time remains to clear most of the bills before the November elections. It is anticipated that the closing out the process will take place some time in December. In order to maintain government funding, Congress will need to begin examining continuing resolution (CR) options before the October 1 start of the new fiscal year.

House Agriculture Committee Releases Farm Bill Draft: On July 5 the House Agriculture Committee released a draft of the House's 2012 Farm Bill, entitled the Federal Agricultural Reform and Risk Management Act (FAARM). The House's bill makes \$35 million in program cuts over ten years, compared with the \$23.6 billion in cuts proposed by the <a href="farm">farm</a> bill passed by the Senate. The bill also proposes a 66% cut in mandatory rural development funding and a 50% reduction in authorization levels for rural development programs.
