# **News from Washington**

Congress is not in session. House and Senate will return on September 8.

#### Overview

When lawmakers return from their August recess, they will face a looming deadline for action on the federal budget, which expires on September 30. Senate Democrats called on their Republican colleagues to begin negotiations over the summer in order to reach an agreement on the automatic spending caps known as sequestration before the September 30 deadline (see story below). President Obama has suggested he would veto any spending measure that applies the caps on domestic programs. Tomorrow, the Congressional Budget Office will release its annual *Budget and Economic Outlook* report with 10-year budget projections.

### OMB Report Shows 2016 Spending Bills Would Exceed Caps

Last Thursday, the Office of Management and Budget (OMB) released its **Sequestration Update Report** for Fiscal Year 2016. Required by the *Balanced Budget and Emergency Deficit Control Act* of 1985, the report shows that the House and Senate FY 2016 defense appropriations proposals, and the House's non-defense appropriations proposal, would exceed the caps set by the Budget Control Act. If the 2016 discretionary caps remain unchanged, the House non-defense bills are \$1.8 billion over the cap. If enacted in their current form, the House defense bill exceeds the cap by \$3 million, and the Senate's defense bill exceeds the cap by \$1 million.

#### EPA Proposes Rule to Reduce Methane Emissions from Oil, Natural Gas Industry

Last Tuesday, the U.S. Environmental Protection Agency (EPA) released a **proposed rule** that aims to reduce methane emissions from the oil and natural gas industry. The rule would require the oil and gas industry to identify and stop leaks in the production process, capture natural gas from the completion of hydraulically fractured oil wells, and limit emissions from certain natural gas transmission compressor station equipment. EPA says that the rule will result in cleaner and more efficient natural gas use and production, which will help states and industry comply with the Clean Power Plan rule. The rule will be available for comment 60 days after publication in the *Federal Register*. Once comments are received, EPA expects to issue a final rule is expected in 2016. #### White House Announces Funding for Drug Trafficking, Heroin Response Strategy

The White House Office of National Drug Control Policy announced \$13.4 million in available funding for the High Intensity Drug Trafficking Areas (HIDTA) program, including \$5 million to reduce the trafficking, distribution, and use of heroin, plus \$2.5 million to support the Heroin Response Strategy, a partnership among five regional HIDTA programs: Appalachia, New England, New York/New Jersey, Philadelphia/Camden, and Washington/Baltimore. The strategy will include a heroin and prescription opioid training curriculum to prepare law enforcement to

respond to the trafficking of heroin, to increase awareness of opioid addiction, and develop links to prevention and treatment resources.

### White House Announces Actions to Boost Renewable Energy and Energy Efficiency

President Obama unveiled a number of executive actions on Monday designed to increase investments in renewable energy and energy efficiency. The orders were created to assist states working to meet new carbon emissions targets under the President's *Clean Power Plan* and bolster a number of other clean energy goals set by the Administration. The actions include a \$1 billion increase to a loan guarantee program for distributed energy projects, \$24 million in financing for several projects aimed at doubling the efficiency of solar panels, and the establishment of a U.S. Department of Defense initiative to install solar energy systems on 40 military bases. Additionally, the White House announced that it will spend \$220 million on energy programs for veterans and low income customers as well as form a task force to focus on boosting energy efficiency in low income households.

### Surging Seas Risk Finder

Climate Central has released a new tool for sea level and flood risk analysis for 21 coastal states. The Risk Finder is a multi-part public web tool that helps communities, planners, and leaders conduct a screening-level analysis of sea level rise and coastal flood risks, using detailed searchable maps; analysis of over 100 variables for 1000s of communities; community comparisons; and local sea level and flood risk projections.
