If local food production were increased in the region, it could create over 5,000 jobs and generate \$6.5 billion per year in economic activity. This new opportunity, provided through FEMA and the Rockefeller Foundation, is designed to continue to move community preparedness forward and assist local areas in building and revitalizing community-based partnerships to advance the nation's resilience to disasters. The highest grant amount is \$35,000, and applications are open to most local, state, and tribal agencies and governments; business entities; associations; organizations and groups. POLICYUPDATE

The House and Senate are in recess until after the November elections; they are expected to return on November 14.

Sequestration Update: On Friday, the White House Office of Management and Budget (OMB) is ordering federal agencies to plan for spending in FY13 as if sequestration is not a factor, stating, "Agencies should continue normal spending and operations." If Congress doesn't address sequestration in the lame duck, in January OMB will enact steps to make the \$109 billion in FY13 cuts. Also, the U.S. Conference of Mayors sent a letter to Congressional leaders signed by 149 mayors around the country detailing the negative impacts sequestration will have on local budgets. Farm Bill Expires: Congress did not take any action on the Farm Bill reauthorization or drought disaster assistance before it left for recess on September 21. Most programs will continue and farmers will receive direct payment checks in October. As part of the FY 2013 Continuing Resolution passed by Congress last week, conservation and other U.S. Department of Agriculture programs will receive funding equal to FY12 levels until March 2013, but all programs will not be able to enroll new participants or sign new contracts until the next Farm Bill is completed or an extension is passed and signed. It is anticipated Congress will take this up in the lame duck session.
