

Colleagues,

Expect a negotiated Congressional Budget Committee approved budget by tomorrow, Tuesday COB. Otherwise, the U.S. House adjourns on Friday for the year, and will either need to pass a short term funding bill or fail to fund the government on January 15. A stopgap measure gives the Budget Committee time to work out budget kinks and fund the government halfway between the 2014 sequester level and the Senate Democrats top-line number – setting a budget agreement at about \$1 trillion. If a deal falls through, Democrats may push separate

PROGRAM UPDATE

Pritzker Launches Next Phase of Advanced Manufacturing Agenda:

Last week, the U.S. Department of Commerce (DOC) Secretary, Penny Pritzker, launched the second phase of the Administration's *Investing in Manufacturing Communities Partnership* (IMCP), an initiative aimed at encouraging communities to develop comprehensive economic development strategies to strengthen their competitive edge in attracting global manufacturers and their supply chains. In the next phase of this program, regions and communities will be eligible to compete for a special designation that will elevate them in consideration for \$1.3 billion in federal dollars and assistance from 10 agencies. In order to earn the designation, communities must present strategies that identify technologies or industries in which their communities would be competitive in the future and would make investments in areas such as

legislation to fix the sequester.

Budget Deal Work Continues: With the end of the week deadline looming, Congress continues to work on a budget deal that would boost overall federal spending and replace part of the sequester. The Budget chairmen in both Chambers are negotiating a regular legislative budget

framework that would provide nearly \$1 trillion in FY14 funding, replace sequestration with alternative, targeted spending cuts, and allow Congress to pass the full package with a single vote in each Chamber and minimize the opportunities for alteration. The framework would minimally raise FY14 spending in exchange for an array of deficit reduction steps in other areas. There are several potential complications, including adding unemployment benefits and an effort being pushed in the House to keep the Budget Control Act's spending requirements, which could derail or delay any full agreement. However, this effort, unlike recent past ones, is focused on easing the second year of sequestration, which is predicted to have even greater impacts, and avoiding government shutdown. The 2011 Budget Control Act (BCA), which enacts budget spending caps and sequestration levels, sets FY14 spending at \$967 billion. House leaders have prepared a separate budget deal that would set spending levels for FY14 and FY15 at BCA levels.

Renewed Optimism in Long-Term Farm Bill Negotiations: Farm Bill negotiations have plodded along for over a month, but last week, conference Committee leaders indicated there could soon be a breakthrough. After a marathon closed-door session on Wednesday, House and Senate negotiators emerged with optimism, though they indicated they didn't expect to move a package before the holiday recess, but House Majority Leader Eric Cantor said he was leaving open the possibility of voting on a compromise bill as early as this week. If negotiations continue into 2014, a short-term extension will be necessary.

Blumenauer Pushes for Gas Tax Increase: In a move that received a lot of attention, Rep. Earl Blumenauer (D-OR) last week introduced the UPDATE Act of 2013, which would follow the recommendation of the Simpson-Bowles deficit reduction report and increase the federal gasoline tax by 15 cents per gallon, nearly doubling it to 33.4 cents per gallon. The bill would also index the gas tax to inflation, so the spending power of the money collected would not erode over time. The federal gas tax has remained unchanged for more than two decades; Blumenauer's proposal would put the tax slightly higher than it would be - had it been indexed for inflation in 1993. December 10, 3:00 PM EST

Under EPA's Greenhouse Gas Reporting Rule, owners or operators of municipal solid waste (MSW) landfills must report emissions from MSW landfills and all other source categories located at the landfill for which methods are defined in the rule. Owners or operators are required to collect emission data; calculate greenhouse gas emissions; and follow the specified procedures for quality assurance, missing data, recordkeeping, and reporting. EPA will cover who is subject to the reporting rule, review an applicability tool that can help facilities determine if they are subject, and address what to do if you must report.
